The collection and use of Authorised Representatives' and Representatives' personal information

- (a) CMLA may collect personal information from the Authorised Representatives and Corporate Representatives. This may include, but is not limited to, their name, contact details, date of birth, driver's licence or other forms of identification the Group considers necessary.
- (b) CMLA may use personal information regarding the Authorised Representatives and Corporate Representatives for the following:
- Identification;
 - Assessing application for registration;
 - Statistical, prudential, risk management, actuarial and research purposes;
 - Assisting customers with queries; and
 - Marketing.
- (c) CMLA may need to disclose the Authorised Representatives and Corporate Representatives personal information to other members of the Group. This enables the Group to provide services and support and to maintain an integrated view of all third parties which the Group undertakes dealings with. From time to time in the ordinary conduct of our business, the Authorised Representatives' and Corporate Representatives' personal information may also need to be disclosed to government organisations, such as ASIC, where we are legally obliged to do so.
- (d) Where personal information is disclosed, CMLA will seek to ensure that the information is held, used or disclosed consistently with the Privacy Laws, and any other applicable Privacy Laws and codes.
- (e) Subject to certain permitted exceptions, Authorised Representatives and Corporate Representatives are entitled to access Personal Information we hold about them.
